**IN THE MATTER OF ESTABLISHING
SPEED LIMITS ON UNPAVED ROADS
IN THE COUNTY OF FRANKLIN,
MISSOURI**

WHEREAS, for the purpose of promoting the public safety, health and general welfare and to protect life and property, the County Commission of Franklin County, Missouri is empowered to adopt, by Commission Order regulations to control vehicular traffic upon the public roads and highways in the unincorporated territory of the County of Franklin, Missouri and to establish reasonable speed regulations in congested areas upon such public roads and highways in the unincorporated County; and

WHEREAS, such regulations shall not be inconsistent with the provisions of the general motor vehicle laws of the State of Missouri; and

WHEREAS, before the adoption of such regulations, the County Commission shall hold at least three public hearings thereon, fifteen days' notice of the time and place of which shall be published in at least two newspapers having a general circulation within the County of Franklin, Missouri, and notice of such hearing shall also be posted at least fifteen days in advance thereof in four conspicuous places in the County; and

WHEREAS, the County Commission of the County of Franklin, Missouri has not previously established speed regulations on unpaved, gravel roads within the County; and

WHEREAS, the County Commission of the County of Franklin, Missouri determines that for the purpose of promoting the public safety, health and general welfare and to protect life and property it is necessary to establish reasonable speed regulations upon the unpaved, gravel roads in the unincorporated County.

IT IS THEREFORE ORDERED, by the County Commission of the County of Franklin, Missouri that the Section 304.010, Schedule I of the Franklin County Municipal Court Code is hereby amended by adding thereto the following:

It shall be unlawful for any person to drive a vehicle at a speed in excess of 30 mph on any unpaved, gravel road in the unincorporated County of Franklin, Missouri.
